Wirecard Terms and Conditions issued by Wirecard Card Solutions Limited, with registered office in: 3rd Floor, Grainger Chambers, 3-5 Hood Street, Newcastle upon Tyne, NE1 6JQ, registered in companies house under no. 07875693, on November 11th 2019, is amended with effect from 5.11.2020 in article 12 - Conclusion as follows:

12.1 We may assign or subcontract any or all our rights and obligations under these Terms and Conditions to any Affiliate party of ours (including Wirecard Bank AG) or Direct Fidoo or its affiliate party, which can provide the Services under these Terms and Conditions.

12.2 The following day after the withdrawal of the United Kingdom of Great Britain and Northern Ireland from the European Union without agreement (No deal Brexit agreement), our obligations and rights under the contract and these terms and conditions will be transferred to Wirecard Bank AG, established Einsteinring 35, 85609 Aschheim, Germany, identification number HRB 161178. Wirecard Bank AG is a company regulated by the Federal

- 12.1 We may assign or subcontract any or all our rights and obligations under these Terms and Conditions and/or the General Agreement without your consent to any third party which can provide the Services under these Terms and Conditions. From the effective date of the change of party providing Services Wirecard and any information related to it in the contractual documentation will be replaced by the name and details of the new party providing the Services. Simultaneously with the change of the Service Provider we may change without your consent bank account referred to in Article 3 of the General Agreement and other information necessary for change of the party providing the Services. For changes according to this article, Article 9 - Changes to contractual documentation does not apply.
- 12.2 Change of party providing the Services and other changed information we will notify you on the permanent data carrier no later than 3 working days before the date on which the change is to take place.
