A beneficial owner of a legal entity (in general) is:

Any natural person who is an ultimate recipient or a person with ultimate control. It is thus explicitly clarified that there may be more than one beneficial owner.

An ultimate recipient of a company is any person who has a direct or indirect right to a dividend, share of other equity resources or liquidation balance of a company exceeding 25 %, and does not transfer it further.

A person with ultimate control in a company is any natural person who is a controlling entity, particularly if its direct or indirect share in the voting rights exceeds 25%.

A natural person for whom a transaction is carried out in the sense of Act No. 253/2008 Coll., on Selected Measures against Legitimisation of Proceeds of Crime and Financing of Terrorism.
